

2019 EPC Pastors Report

Beloved community of Edgcumbe Presbyterian! It seems unimaginable, but this past August marked our 13th year walking together...and for this review of 2019, a wider scope of reflection seems right.

The year 2019 began with a conference entitled, "Canoeing the Mountains," with a metaphor to help understand church at this time. It was suggested that Lewis and Clark, upon their mission to find a water passageway to the Pacific Ocean, traveled by a canoe using the available waterways. Once they hit the Rocky Mountains, they hauled the canoes up the mountain with the belief that the next waterway was just on the other side. However, once they arrived at the top, they were dismayed to view mountains as far as they could see.

Pastors Report Continued

The conference suggested that the current "church," like the canoe--it was the right craft for American Christianity when Christianity was the dominant culture. It flowed easy within the landscape, but as the culture has more influences, including the largest set of people who identify as non-religious, the "church," like Lewis and Clark, needs to re-orient and re-adjust for a different kind of traveling into the future, instead of dragging old models and expectations of the church along.

As the community engaged these ideas, we realized that in many ways, EPC is well underway in the process of letting go of the former structure and patterns of church. What we didn't know 13 years ago was that our shared ministry at Edgcumbe Presbyterian was at the top of the Rockies, and our job was to support the communities' evolution into a new way of being. Our Sacagawea has been the Holy Spirit, and we can see now how, over these years, the canoe of the EPC has been slowly unweaving its form, as old committee structures have fallen away. There has always been a good people with great hearts within the community, but as we have centered on worship and deepening spiritually into trust of God, we are now emerging with practice of listening to and following the Holy Spirit. Just last month, our Session recognized that during the transition years there seemed to be a focus of survival, but now as we see the growing freedom in our lives, new folks wanting to be a part of our community, and the strongest church budget in decades, we are thriving! We have evolved through the stress of the process, emerging committed to God, to each other, and to being instruments of God's love and grace.

We also took a deep dive into the practices of forgiveness. We explored new ways to understand and practice forgiveness, with the anchoring in our at-one-ment in God. We find the willingness to practice forgiveness when we recognize that only love is real, and that God is our only goal. God is the Love in which we forgive. Forgiveness is the acceptance of the at-one-ment, knowing nothing could (or has ever) separated us from the Love of God.

Our final deep dive was to explore the ideas around community, and why is community worth our time, attention and intention. Yes, you can have a personal, dynamic relationship with God, but as we live on a planet with others, often our deepest healing comes through community. This seems like a particularly relevant gift as we live in a time where we are saturated by our larger culture to draw lines with our differences. Even as we navigated some disagreements this past fall, we emerged more fully committed to each other. We know that we are each a vital part of the Body of Christ, and we need each other to be whole!

So--whew!! So much evolving, so much growth, and so much beauty in a year!! Personally, this deep evolution is also true at the personal levels in our lives, as well as our children as they age through the teenage years and are now beginning to launch. Also, Pastor Phil's work as faculty of the national Enneagram Prison Project, and Pastor Julie's walking pilgrimage on the Camino de Santiago continue to deepen our own growth and healing.

We simply want to close by saying what an honor it is to serve alongside of you this amazing community of the Living Christ. Holy Spirit, in this holy moment, you be in charge, and we will follow you, trusting that your direction leads to peace. Blessed Be!

TERMS (all should be annual):

Salary & Housing: \$52,395.60 (Includes housing allowance of \$20,000) Note: This salary is 90% of \$52,924.86 (the Presbytery minimum salary) plus a 10% increase for experience and merit, as recommended by the Session.

>Vacation: one month

Note: Pastors Julie and Phil share one position, so the position gets this time off—meaning that Julie and Phil take their time off together. They do not each get a separate month of vacation. This same logic applies to Continuing Ed time and Sabbatical.

>Continuing Education allowance \$2,400 (cumulative over 3 years to \$7,200)
>Continuing Education leave: 2 weeks (cumulative over 3 years to 6 weeks)
>Pension and Medical: Full family coverage
>Automobile allowance: IRS rate Vouchered up to \$800

>Medical/Dental Supplemental: Vouchered up to \$4000

Building & Grounds

For a building that is now 65 years old, we have not had any major catastrophes or system failures for the past few years. We do have a list of concerns and places that need improvement, and 2019 was a year when we saw progress in several areas. Here is a partial list.

- After Spring thawing caused flooding from both the roof and in the basement, we responded with both emergency roof shoveling and downstairs clean-up (thanks to the many helpers!) and re-grading the area outside the church office (thanks to Lorenz and nephew Hung).
- The education wing window sills on grade with the parking lot had been rotting for several years. When those same windows were vandalized this year, it gave us the chance to put in new sills and repair the windows.
- With some concerns for our aging electrical system, we got bids for upgrades between \$10-40,000. Enter electrical engineer Dean, who assured us that things were not so dire and offered his help to solve problems as they arise--thanks, Dean!
- Tom Holt fixed the kitchen sink that had been leaking for 15 years; Lorenz installed a handle in the basement door; Jay hung a railing next to the pulpit; Dean found a replacement door opener; Ron Eggert mowed the lawn; Kathy Young washed windows, cleaned up more sticks than can be counted, and kept the front gardens beautiful Spring through Fall.

Caring for our 3.8 acres of land and aging building is a big job, but this congregation does a wonderful job of working together to make it happen. We are very close to addressing the next big concern, which is replacing the tile flooring in the office hallway and kitchen level, including abatement of the old asbestos tile and glue.

Between church ministry, the Preschool Monday-Friday, Backwoods walkers, and approximately 700 people coming monthly to 12-Step meetings, this little church in the woods gets a lot of use, brings in a fair income to this congregation, and blesses many, many people.

Backwoods

edgcumbe presbyterian has long been desired to create space to our broader community to be nurtured. we have lived this out by hosting 12 step meetings, sharing our space with edgcumbe montessori, and now with the development of our backwoods ministry. we have seen such a broad spectrum of folk use this space-12 step folk, people from highland park high school, and our neighbors, as well. it is one of the ways we practice generosity, by developing spaces which nurture the spirits and souls of all people, however they understand the sacred. we also hosted a "pop-up" centering prayer meeting for the mn contemplative outreach this fall, and we hope to continue this as well.

our community has been supported these past few years by gordy rosine, a man who the holy spirit connected with us!! he has personally drafted plans, created stages of work, and helped research what are the best plants to support our backwoods. in addition to this, he has personally been in our woods with shovels, wheelbarrows, and trailers doing the actual hard labor alongside of us. truly, we would be still in our early stages if not for gordy--thank you!!

this past year, our walking meditation path was fully wood chipped by isaac gebbengreen's senior project. and now each prayer site has at least one chair for people to sit and reflect. we also received

the gift of granite markers by connie howe-vielmetti's brother-in-law, steve, which we need to figure out how to best post at each station.

here is where we could use your help directly. please ponder how you might support this ministry in the next year:

- we would like to host a community open house for our backwoods this year. it would be super helpful if someone is identified to chair that event, and help organize the epc community and communicate to the broader highland park;
- any kind of support for the ongoing work such as the pulling of buckthorn, pulling weeds, watering new plants, etc. this might sound like "work", but i have found that simply being in the backwoods, tending the earth, encountering the wildlife has been very nurturing to me personally. i invite you to deepen your prayer practice by being in the backwoods!!

finally, so many places for other gratitude: for the members who have helped and tended to the woods this past year, for pastor phil and his hard labor, for gordy, to our neighbor-dave busch- who allows us access to his watering hose and various other loans of equipment, and to the presbytery of the twin cities for the grant they gave us, for which we are still utilizing for our purchases.

the backwoods are amazing.... i invite you to wander up there regularly and encounter the healing woods yourselves!! pray at a station, swing on the bench, walk the labyrinth, breathe. it is such a nurturing space!!

Finance & Stewardship

Our finances are in good shape, better than at any time in the past 5 years, thanks to those who have fulfilled their pledges, those who have given more than their pledges, the increasing number of members and attendees, and a fiscally conservative Session and staff. As of this date we have over \$40,000 in our checking (for current expenses) and savings (special projects) accounts and over \$45,000 in our Vanguard rainy-day account. However, a need to replace tile flooring in the library, hallway, back hall, kitchen and part of the nursery school will cost approximately \$20,000. Hopefully some or all of this latter amount can be raised through a special offering, saving our rainy-day fund for a true emergency. Additional projects for me include upgrading our church computers. The 2020 Session-approved budget is included with the Annual Report: if there are questions about it, please ask me.
